

Alternative Provision Consent Form

As the school will have explained, AP is a programme to offer your child the opportunity to gain work experience and develop skills outside of the school environment with carefully selected training providers.

The AP scheme is coordinated and administered by Ealing AP, who will review the referral forms and find an appropriate training provider. This will require information about your child to be disclosed to Ealing AP and the selected training providers to help support your child during the programme. Other than sharing information/data with your child's mainstream school, Ealing AP or the training provider will not disclose this information to any other party without your permission, unless there is a legal requirement or duty to do so, or if there is a risk of serious harm or threat to life.

All providers are required to ensure health and safety and insurance requirements are met. However, there will be times (for example, during breaks, lunchtimes, or possibly while travelling to and from the placement) where your child may be unsupervised. This also includes occasions where your child leaves the site before the normal finishing time. In such circumstances, every effort will be made to inform you.

I will report immediately any request for personal information, to a member of staff if I am in school or parent/carer if I am not in school.	
•	I should never post photographs, videos or livestream without the permission of all parties involved.	
•	I will not upload any images, videos, sounds or words that could upset, now or in the future, any member of	
•	the school community, as this is cyberbullying. I will be respectful to everyone online; I will treat everyone the way that I want to be treated. I will ensure that all my online activity, both in and outside school, will not cause distress to anyone in the school community or bring the school into disrepute.
